## VISITOR AGREEMENT

ANY PERSON OR ENTITY ("User" or "You") VISITING, USING OR OTHERWISE ACCESSING THE SITE AT [www.AirPeaceOfMind.com](http://www.AirPeaceOfMind.com) ("Site") OR VIA THE APP KNOWN AS "Air Peace Of Mind" ("App") OR ANY OF THE INFORMATION CONTAINED WITHIN THE SITE OR THE APP AGREES TO AND IS BOUND BY THE FOLLOWING TERMS AND CONDITIONS OF THIS VISITOR AGREEMENT ("Agreement").

- AirPeaceOfMind.com**. The Site and the App together with all content, data and other materials contained therein ("**Content**") is owned or controlled by Air Peace of Mind Ltd, a company incorporated in England with its registered office at The Refinery, 13 Radnor Walk London SW3 4BP, UK. Air Peace of Mind Ltd is referred to in these terms and conditions as "**we**", "**us**", "**our**" or "**APOM**".
- Registration**. If you wish to register to use the APOM Service in any way, you must agree to the terms of the [Registered User Agreement](#). If you wish to register to use the APOM Service to book a Property as a Guest, you must also agree to the terms of the [Rental Agreement](#) or if you wish to register to use the APOM Service to offer your Property as a Client/Host, you must agree to the terms of the [Client \(Host\) Agreement](#).

APOM reserves the right to deny any or all access to the Service to any User for any reason, at any time, in our sole discretion. We reserve the right to take any action we may deem appropriate in our sole discretion with respect to violations or enforcement of the terms of this Visitor Agreement, and we expressly reserve all rights and remedies available to us at law or in equity.

13. **Severability.** If any part, term, or provision of this Agreement shall be held by a court of competent jurisdiction to be illegal, unenforceable, or in conflict with any relevant law, the remaining portions or provisions shall still remain valid and continue in full force and effect.
14. **Changes to this Agreement.** This Agreement and/or any other terms of service may be changed without prior notice, and any such amendment will be applicable to all Users from the date and time such revised terms have been posted on the Site or the App (or otherwise made available to you). User's continued use of the Site, the App, the Content or services provided by APOM, constitutes agreement with and acceptance of any such amendment or other changes.
15. **Law and Jurisdiction.** This Agreement shall be governed by and will be construed in accordance with English Law. Any disputes arising under or in connection with this Agreement shall be subject to the exclusive jurisdiction of the English Courts.
